There being a sufficient number of members of the corporate authorities in attendance to constitute a quorum, the meeting was declared in order.

Please find following a brief synopsis of administrative activities for the months of June and July.

#### ADMINISTRATION, BUILDING AND PUBLIC WORKS

#### Communication

Staff worked steadily through the month of June on the telecommunications concerns and is presenting a proposal to you this evening under separate cover to move phone and internet services to Comcast for reliability and cost savings reasons.

I have now completed SWOT sessions with the local government agencies and a core business group. The next step will be to send out the SWOT to all businesses in hopes of some feedback and then consolidate the results for presentation to the City Council in another workshop. The outcome of the workshop will be a set of achievable goals and objectives which will be presented to the residents for feedback before implementation.

#### **Finance**

Staff has been meeting virtually with our Liability Insurance Pool members to determine if we want to stay with our current Insurance Provider or move on to another. We are waiting for quotes and will present the Council with our findings closer to September.

#### Planning and Economic Development

On June 8-10, I attended the Illinois City County Managers Association's Summer Conference. This conference was well attended and afforded me the ability to network with my peers on areas of importance to the City of Wilmington. Two of the sessions I attended were titled Cracking the Downtown Secret Using Local Assets, Arts, and Diversity and Six Tips to Maximize your Budget for Public Infrastructure. Key take aways from the Public Infrastructure Session include:

1) Grow Your Budget By Finding Outside Funding

- 2) Take a Value Engineering Approach
- 3) Don't Reinvent the Wheel
- 4) Stay Resilient with Asset Management
- 5) Use Staff Augmentation for Peak Workload or Special Skills
- 6) Review Your Fee Structures

Key take aways from the Downtown Session include:

- 1) Use Historic Tax Credits and Create Incentives and Development Tools
- 2) Create a Small Business Retention Program
- 3) Consider Shop Local Grow Local Programs
- 4) Find Grants for Brownfield Redevelopment
- 5) Forge Critical Partnerships with business focused organizations
- 6) Create a Strategic Plan and Branding Campaign
- 7) Encourage 360-degree Design for Beautification Projects
- 8) Update Zoning Code for Flexibility and Context Sensitive Design

#### Special Events

Over the course of the last five months, staff has spent time planning the City's first Let Freedom Rock event. This was a highly collaborative effort and I would like to thank our Park District, Park Foundation and Fire Protection District Partners as well Joie Ziller, Chief Mitchell, James Gretencord, and Dennis Housman for your enthusiasm, expertise, and creativity in creating a well-attended and well-run event!

On June 28<sup>th</sup>, I attended a Kankakee Watershed meeting with stakeholders from all along the Kankakee National Water Trail. Hosted by former interim City Administrator Frank Koehler, the alliance began planning a conference to be held in March of 2023 and will consist of a one-day workshop focusing on the Kankakee River Watershed. Topics of discussion include: water quality, biodiversity, sand and sediment, river recreation & watershed initiative, and the importance of the Kankakee River to Bi-State Economy. Staff will keep you apprised of our progress as we move through the planning stages.

#### **Utilities**

On June 22<sup>nd</sup> the Mayor and I met with Director Gretencord and members of the Water Department to discuss the City's water system, problems and solutions. The team will meet monthly until we have reduced water loss numbers to acceptable percentages. Staff will report on our findings to the City Council periodically.

Subject: Monthly Status Report – June 2022 and Semi-Annual Calls for Service and Crime Statistics

#### During the month the patrol division had the following activity:

- 17 Pedestrian/Suspicious Stops were conducted
- 152 Business (Walk and Talk) Checks (officers entering businesses during normal hours)
- 10,672 Premise Checks (officer checking cursory checks of businesses after hours
- Officers made 4 misdemeanor and/or warrant arrests
- Officers made 1 felony arrest
- Officers issued 126 written traffic warnings
- Officers issued 44 compliance (local ordinance) tickets (100% increase vs May 2022)
- Officers issued 4 parking tickets
- Officers handled an additional 588 calls for service and wrote 55 related reports.
- Thirty-Five (35) trucks were weighed based on a suspicion of being overweight

#### Investigations Division had the following activity:


- Closed Five (5) active cases; One 1 warrant issued (felony), Three (3) administratively closed and one (1) unfounded.
- Seven (7) new cases were assigned.
- Nine (9) Cases awaiting State's Attorney review.

#### Training:

- Ten (10) officers received firearm training (twenty-five (23) drills and Deadly Force Review), and 9 range days were utilized by visiting LE agencies.
- Officers participated in a total of 83 hours of off-site training.
- Each officer participated in 27 Lexipol daily training scenarios.
- The Department contracted with the Police Law Institute to obtain online training to work towards compliance with Illinois Law Enforcement Training and Standards Board (ILETSB) required training under the SAFE-T Act and has made great strides to come into compliance with all the unfunded training mandates including recent training on Hate Crimes.
- All members have completed five (5) online training courses (approximately one (1) hour each in length) including Hazardous Materials.
- Two recruits, Michael Pitsenberger and Brandon Warick, began the Illinois State Police Academy on April 24, 2022 and are scheduled to graduate on July 28, 2022. Both are excelling academically.

#### **Administration:**

• Authored two (2) ordinances to increase the fine amounts for prohibited access into the Exclusionary Zone and for Overlength, Height and overweight trucks operating on non-designated truck routes.







### Semi-Annual Crime Statistics and Select Calls for Service


Provided below are graphical illustrations of the semi-annual crime statistics and specific calls for service performed by the Wilmington Police Department in the first six (6) months of 2022:



The Wilmington Police Department has seen a drop in violent crime when compared to the same time period in 2021.






The number of cleared cases by arrest are within a satisfactory range when compared to regional and national averages (FBI Statistics).



Chapter 74 - Equipment and Loads

Article 1. - Operation of Golf Carts and Non-Highway Vehicles

#### 74.01 - Definitions.

For the purposes of this article, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

"City Streets:" Any of the streets within the boundaries of the city of Wilmington except for state, county and township roads.

"County Roads:" Any road under the jurisdiction of Will County Highway Department.

"Golf Cart:" A vehicle specifically designed and intended for the purpose of transporting one or more persons and their golf clubs or maintenance equipment while engaged in the playing of golf, supervising the playing of golf or maintaining the condition of the grounds on a public or private golf course and having a maximum speed of 20 miles per hour (mph).

"Non-Highway Vehicles:" As defined herein, means any motorized off-highway device designed to travel primarily off-highway, up to 82 HP, 64 inches or less in width, having a manufacturer's dry weight of 2,000 pounds or less, traveling on four or more non-highway tires, designed with side by side bench or bucket (non-straddle) seating, steering wheel, pedals for break and gas with a maximum speed of 45 miles per hour (mph).

"State Roads:" Any road under the jurisdiction of the Illinois Department of Transportation. State roads include, but are not limited to IL Route 102, IL Route 53, Interstate 55, and frontage roads.

"Township Roads:" Any road under the jurisdiction of a township road district.

#### 74.02 - Operating requirements.

Except as otherwise provided in this chapter, it shall be lawful for a person to drive or operate a golf cart or non-highway vehicle upon city streets in the city of Wilmington.

- a. A person shall not drive or operate a golf cart or non-highway vehicle upon any roadway in the city of Wilmington without a valid driver's license.
- b. It is unlawful to drive or operate a golf cart upon or non-highway vehicle on any roadway in the city of Wilmington with a speed limit greater than thirty-five (35) miles per hour. Provided, however, a golf cart or non-highway vehicle may cross a roadway at an intersection where the

- roadway to be crossed has a posted speed limit of more than thirty-five (35) miles per hour.
- c. Any person driving or operating a golf cart or non-highway vehicle shall not cross any state, county or township road, toll road, interstate highway, or controlled access highway unless at an intersection controlled by a traffic light or a four-way stop sign and the speed limit of the highway to be crossed is thirty-five (35) miles per hour or less at the place of crossing.
- d. A golf cart or non-highway vehicle shall only be driven or operated on roadways under the exclusive jurisdiction of the city of Wilmington unless the city has concurrent jurisdiction with another unit of government controlling the roadway and authorizes the same.
- e. A person who drives or is in actual physical control of a golf cart or non-highway vehicle while under the influence is subject Sections 11-500 through 11-502 of the Illinois Vehicle Code, including but not limited to Driving Under the Influence (625 ILCS 5/11-501) and Illegal Transportation or Possession of Alcoholic Liquor in a Motor Vehicle (625 ILCS 5/11-502), and applicable local ordinances.
- f. Golf carts and non-highway vehicles shall not be operated on sidewalks or other public property not accessible to or authorized for vehicular traffic.
- g. A person who drives or operates a golf cart or non-highway vehicle shall obey all traffic laws of the State of Illinois and the city of Wilmington with regard to the movement and operation of vehicles on the streets and roadways.
- h. It is unlawful to operate or drive any non-highway vehicle, as defined by Section 11-1426.1 of the Illinois Vehicle Code (625 ILCS 5/11-1426.1), besides a golf cart or non-highway vehicle, on any roadway in the city of Wilmington.

#### 74.03 - Equipment requirements.

A golf cart or non-highway vehicle shall not be operated on any roadway in the city of Wilmington, unless at a minimum, it has the following in a working and operable condition: brakes, seat safety belts, a steering apparatus, tires, a rearview mirror, red reflectors in the front and rear, a slow moving emblem (as required of other vehicles in Section 12-709 of the Illinois Vehicle Code) on the rear of the golf cart or non-highway vehicle, a headlight that emits a white light visible from a distance of five hundred (500) feet to the front, a tail lamp that emits a red light visible from at least one hundred (100) feet to the rear, brake lights and turn signals. All golf carts and non-highway vehicle shall have their headlights and tail lamps illuminated when driven or operated upon a roadway in the city of Wilmington as required by section 12-201 of the Illinois Vehicle Code.

74.04 - Mandatory insurance.

Any person who operates a golf cart or non-highway vehicle on a street, roadway, or public alleyway shall be subject to the mandatory insurance requirements under Sections 7-601 through 7-610 of the Illinois Vehicle Code.

#### 74.05 - Registration required.

It shall be unlawful for a person to drive or operate a golf cart or non-highway vehicle upon any roadway in the city of Wilmington unless the golf cart or non-highway vehicle is registered with the Wilmington Police Department and conspicuously displays a valid and corresponding registration number placard/sticker on the passenger side of the rear bumper on the golf cart or non-highway vehicle.

- (A) Upon the adoption of this ordinance, and annually thereafter, all owners of golf carts or non-highway vehicle shall apply to register their golf carts or non-highway vehicle with the Wilmington City Hall by fully and truthfully completing a registration application. In order to register, the golf cart or non-highway vehicle shall be subject to inspection by the Wilmington Police Department.
- (B) The registration and the corresponding placard/sticker shall be valid for a period of January 1 through December 31 of the same calendar year.
- (C) A nonrefundable registration fee of twenty-five dollars (\$25.00) shall be paid to the city of Wilmington with each application or reapplication for registration.
- (D) Registration shall be subject to revocation in the event the Wilmington Police Department determines the applicable insurance policy for the golf cart or non-highway vehicle has been revoked, has lapsed or is otherwise invalid.
- (E) All owners of golf carts or non-highway vehicles registered with the Wilmington Police Department will be issued a corresponding registration number placard/sticker, which shall be affixed and remain conspicuously visible on the rear of the golf cart or non-highway vehicle.

#### 74.06 - Capacity limitations; seat safety belts and child restraints required.

- (A) It shall be unlawful for any person to drive or operate a golf cart or non-highway vehicle upon any roadway within the city of Wilmington while transporting or carrying more occupants than seat safety belts on the golf cart.
- (B) Each driver and passenger of a golf cart or non-highway vehicle operated on any roadway

within the city of Wilmington shall wear a properly adjusted and fastened seat safety belt.

(C) A child less than eight (8) years of age shall not be transported in a golf cart or non-highway vehicle unless properly secured in an appropriate child restraint system, or otherwise protected as required by Section 4 of the Child Passenger Safety Act. Each driver of a golf cart or non-highway vehicle transporting a child eight (8) years of age or more, but less than 16 years of age, shall secure the child in a properly adjusted and fastened seat safety belt. The transportation of a child eight (8) years of age or less is prohibited unless the child is accompanied by the child's parent or guardian or a person twenty-one (21) years of age or older other than the driver.

#### 74.07 - Penalty.

Any person found to be in violation of this ordinance shall be subject to a fine of not less than \$75.00, and not more than \$750.00. A separate offense shall be deemed committed on each day during and on which a violation occurs or continues.

No site usage agreement or any other click through agreement required to access a website or on a website will have any binding effect whether STANLEY clicks on an "ok," "I accept," or similar acknowledgment. Terms contained or referenced in Customer facility sign-in logs, safety waivers or other similar documentation are hereby rejected and shall not have any binding effect on STANLEY or its employees. Customer's order of any Services or acceptance of delivery of any Parts manifests Customer's assent to the Agreement. Additional or different terms applicable to a sale may be specified in the body of a STANLEY Document or agreed to in writing by the parties in a Service Contract. In the event of a conflict, the following order of precedence will apply: (a) terms agreed to in writing and executed by an authorized STANLEY representative in a Service Contract; (b) STANLEY Document terms; (c) these Terms.
- 2. Pricing; Payment. Prices and rates are in local currency and are subject to change without notice, unless otherwise set forth in a Service Contract. Unless otherwise stated on a Service Contract, all payments are due within 30 days of the invoice date. STANLEY may withhold Services and Parts for past-due invoices. If an invoice is past due for 60 days or more, STANLEY may terminate the applicable Service Contract or this Agreement and Customer will owe, in addition to the past due invoice amounts, for any Service that is performed during the non-payment period at STANLEY Rates, as defined herein, and standard Parts rates. Late payments are subject to a charge equal to 1.5% per month of the amount outstanding or the maximum allowed by law, whichever is less. Customer shall reimburse STANLEY for all costs and expenses (including attorney's fees) in collecting any overdue amounts and enforcing the terms hereof.
- 3. Service. STANLEY will perform Services and provide Parts as set forth in the applicable Service Contract through its Service Account Manager or other authorized individual. STANLEY will perform the Services during the days and hours listed on the Service Contract ("Business Hours") at no additional cost to Customer. Unless otherwise set forth in the Service Contract, additional charges apply for (i) Services and travel time performed at Customer's request outside of Business Hours, (ii) transportation and handling charges as set forth in the Service Contract, (iii) any other Services which STANLEY performs for Customer at the Customer's request not specifically included in the Service Contract. Permits required for performance of the Services are the responsibility of the Customer or the applicable third-party contractor. Taxes, if applicable, shall be assessed at rates in effect at time of invoicing. STANLEY or Customer may terminate this Agreement at any time with thirty (30) days prior written notice to the other party; provided that if the Customer terminates under this sentence, Customer shall remain obligated to pay for all services performed by STANLEY through the date of termination.
- 5. Parts. An automatic door system that does not conform to codes or regulations, including ASNI 156.10 can cause serious damage to property as well as serious personal injury or death. In no event will STANLEY be responsible for any loss or damage arising out of Customer's improper selection, misapplication or misuse of a part furnished by STANLEY
- **6. This month, the Street Department was busy completing several tasks to ensure our Independence Day celebration was successful. In addition, the crew continues to work on buffalo box repairs, asphalt, and concrete patching.

D Construction has begun the flume project by removing old meters and replacing them with spool pieces at the Sewage Plant head works facility. We will be by-passing the head works starting Monday, July 25th in order to remove the concrete to install the flume. This will require our operators to work a rotating schedule of 12 hours shifts for approximately one week in order to have an operator on duty around-the-clock to keep the diesel by-pass pumps operating.

We have started our NARP Study with a kick-off meeting from Geo-Syntec Consultants.

The Water Treatment Plant building replacement has a scheduled start date of Friday, August 5th. The Water Department has been working on re-routing piping in order to complete this project seamlessly.

The Water Department has received their new Meter/Service Van. The crew has been completing meter inspections in order to get measurements and required fittings to change some of our larger commercial meters. They have also completed 36-meter changes in the month of June.

#### PLANNED MAINTENANCE AGREEMENT TERMS AND CONDITIONS

These Planned Maintenance Agreement Terms and Conditions, together with the Quote on the front side and the Scope of Services, are hereinafter referred to as this 'Agreement' and shall constitute the entire agreement between the customer identified in the Quote ('Customer') and Cummins Inc. ('Cummins') and supersede any previous agreement or understanding (ond or written) between the parties with respect to the subject matter of this Agreement. No prior inconsistent course of dealing, course of performance, or usage of trade, if any, constitutes a waiver of or serves to explain or interpret this Agreement. Electronic transactions between the customer and Cummins will be solely governed by this Agreement, and any terms and conditions on Customer's website or other internet site will be null and void and of no tegal effect on Cummins. In the event Customer delivers, references, incorporates by reference, or produces any purchase order or document, any terms and conditions related thereto shall be null and void and of no legal effect on Cummins.

- 1. SCOPE OF SERVICES; PERFORMANCE OF SERVICES. Cummins shall perform the maintenance ('Services') on the equipment identified in the Quote ('Equipment') in accordance with the schedule specified in the Quote. The Services include those services defined in the 'Service Event' section of the Quote. No additional services or materials are included in this Agreement unless agreed upon by the parties in writing. Unless otherwise indicated in the Quote, Cummins will provide the labor and tools next and shall keep Customer's property free from accumulation of waste materials caused by Cummins' operations. Either party may terminate this Agreement with or without cause by providing thirty (30) days written notice to the other.
- 2. CUSTOMER OBLIGATIONS. Customer shall provide Cummins safe access to Customer's site and arrange for all related services and utilities necessary for Cummins to perform the Services. Re: Comcast for Phone and Internet Services

**Budget Impact:** Estimated \$3,400 annual participation cost

**Request:** Authorization to enter into a contract with Comcast for phone and internet

services

**History:** One of the first internal concerns staff brought to my attention is the

reliability issue of the City's phone service. In 2021, Chief Arnold initiated the replacement of the then existing AT&T Service with Verizon and Intwine (who provided fax and alarm service) and these services have been failing intermittently. Attached you will find a log sheet labeled Tcomm Maintenance which identifies many of the issues including static on the line, fax machine not working, dropped calls and call forwarding not working. Attempts to work with Intwine and Verizon to correct the

problems have proven unsuccessful.

When we began looking into the problems, it was noted that the City currently has 5 telecommunication vendors it is working with. For efficiency reasons I suggested reducing the number of vendors to our IT Consultant, Gary Fuqua. Together we identified there would be significant cost savings by doing so (see attached spreadsheet titled Est.

Monthly Average Since Jan 2022).

Over the course of the last few months, Gary has been migrating the Intwine services over to Comcast due to serious reliability issues we were experiencing. Now we are ready to migrate the phone lines. Please note that this will be a staged process so that we can preserve continuity of service.

It is important to note that once the currently used and identified phone lines are transferred, we will need to research a series of remaining lines on the Verizon bill that will either be ported over to Comcast or eliminated (such as old fax lines that have been unused but for which we have been paying for).

In total, staff has identified an estimated \$892.92 in cost savings monthly by switching to Comcast. The total package includes free phone equipment, the waiving of activation costs and 3 free tv boxes at each of our locations (see Comcast Business proposal attached). While this may sound strange, having access to cable television is important to staff when they are taking meal breaks and so that we may remain updated when important news events are occurring.

The City was recently approached by the Wilmington Library Director regarding a collaborative approach to communicating with residents through a newsletter that will be delivered to their homes. There has been much discussion on social media as well as in group events hosted by the Library District and the Park District that residents are unaware of important events, projects, meetings, etc... happening within the city limits. Even though we create a newsletter monthly and post it to our website and Facebook, there is a segment of the population that is not receiving the information and feel separated due to lack of internet access or ability.

Staff has discussed the matter internally and believe that it is an expensive venture to create a newsletter funded solely by the City; however, a quarterly newsletter funded by the three partners (being the City, Library, and Park District) is much more affordable and will provide another means of communicating with residents. There is also the potential for ad space which would help us recuperate costs. Attached is the discussion thread between the City, Library, and Park District for your review. The newsletter would be published locally by the Free Press and design will begin on the approval of the City, Library and Park District governing

Processing of mailing is \$120
