Re: Utility Billing – Delinquent Accounts

As of July 1, 2022 we have a total of 545 accounts with past due balances. This is a decrease of 15% (97) vs. May. Of those accounts, 84% are less than 90 days past due. After a sharp decline in February, the number of delinquent accounts steadily rose to a 10-month high. The trend then reversed itself and fell to a more or less historical average. Ostensibly, this is due to the rising inflationary pressure in the broader economy.

Since the meter replacement program began in late July of 2021, we have replaced 336 meters. Of those meters replaced, 261 were residential and 90 were for commercial properties. Approximately, 100 meters are still being estimated.
