

Resolution No. 2015-17

**Resolution Designating Meeting Dates and Times and Holiday Observances in 2016
for the Corporate Authorities and Commissions of the City of Wilmington**

Whereas, Section 42.03 of Chapter 102 of the Illinois Revised Statues (1989) requires the City of Wilmington to prepare and make available a schedule of all regular meetings for the coming calendar year listing the times and places of such meetings; and

Whereas, it is therefore necessary for the Mayor and the City Council to set dates and times of the regular meetings of the Corporate Authorities in 2016.

Now therefore, be it resolved by the Mayor and the City Council of the City of Wilmington:

4. That the dates of the Police and ESDA Committee of the City of Wilmington in 2016 shall be on the second Tuesday of the month at 5:30 pm unless otherwise noted.
5. That the dates of the Ordinance and License Committee of the City of Wilmington in 2016 shall be on the second Tuesday of the month at 6:00 pm unless otherwise noted.
6. That the dates of the Water, Sewer, Streets and Alleys Committee of the City of Wilmington in 2016 shall be on the second Wednesday of the month at 6:00 pm unless otherwise noted.
7. That the dates of the Buildings, Grounds, Health, Safety and Parks Committee of the City of Wilmington in 2016 shall be on the second Wednesday of the month at 5:30 pm unless otherwise noted.

11. That the City Clerk is hereby directed to supply a copy of this Resolution to any news medium that have filed an annual request for such notices.


